



Rules for receiving remuneration via a promo code during the Promotion (hereinafter referred to as the Rules)

1. Main Provisions:

- 1.1. These Rules govern the procedure for receiving, terms of use and conditions for crediting remuneration via promo codes (hereinafter referred to as the "Promotion").
- 1.2. The purpose of the Promotion for the Organizer: increasing user activity, attracting attention, increasing awareness and loyalty, maintaining and raising the interest of potential users in the services of the Organizer.
- 1.3. The organizer of the Promotion is Broex (Husky Fintech OÜ), legal address: Harju maakond, Tallinn, Haabersti linnaosa, Meistri tn 16-401, 13517 (hereinafter referred to as the "Organizer").

- 1.6. The Promotion is not a lottery or any other risk-based game, and the participants of the Promotion do not bear any property risks associated with participation in the Promotion. The prize fund of the Promotion is formed exclusively at the expense of the Organizer.

2. Time Period of the Promotion

- 2.1. The timing is determined at the beginning of each Promotion.
- 2.2. The organizer of the Promotion has the right to extend the timing of the Promotion or early completion of the Promotion, change the terms of the Promotion without notice.

3. Terms of the Promotion and the procedure for receiving remuneration via a promo code:

- 3.1. Places where draws can be held and promo codes be published:
 - 3.1.1. Official social networks of the Organizer;
 - 3.1.2. At the Organizer's partner bloggers.

- 3.2. Users of the Organizer's website can receive rewards on their deposit in their personal account on the Organizer's website when using promo codes.
- 3.3. To receive a bonus reward, a verified account on the Organizer's website is required or a successful completion of account verification on the Organizer's website when using a promo code which is valid only during registration of an account on the Organizer's website.
- 3.4. Compliance with the terms of the Promotion:
 - 3.4.1. Entering a valid promo code, which is valid when registering the Participant's account, and successful pass of the account verification on the Organizer's website;
 - 3.4.2. The required activity in social networks, which are specified in clause 3.1;
 - 3.4.3. Required user activity (depending on the promotion, for example, making a deposit) on the Organizer's website;
 - 3.4.4. Compliance with the validity date of the promo code;
 - 3.4.5. Entering of a valid promo code, which is valid only for already registered users on the Organizer's website and who have verified their account on the Organizer's website.
- 3.5. To receive a reward via a promo code, within the time specified in clause 2.1. the user must:
- 3.6. If the promo code is valid only during registration:
 - 3.6.1. You must enter all the required data for registration;
 - 3.6.2. Enter a valid promo code in the "Promo code" field on the account registration page on the website <https://broex.io/login#registration>;
 - 3.6.3. Accept the terms of personal data processing https://broex.io/assets/docs/terms_of_use.pdf and the privacy policy https://broex.io/assets/docs/privacy_policy.pdf ;
 - 3.6.4. Successfully pass the verification of your account (in the settings of your personal account, the status "Your documents have been checked and confirmed" is received).
- 3.7. If the promo code is valid for already registered users:
- 3.8. Only after successful completion of the account verification (received the status "Your documents have been checked and confirmed"):
 - 3.8.1. You need to go to your personal account on the Organizer's website <https://broex.io/private/> ;
 - 3.8.2. Click on the tab "I have a promo code";



- 3.8.3. Enter a valid promo code in the “Enter your promo code” field;
 - 3.8.4. Click on the "Use" button.
 - 3.9. When you enter a promo code, if your account is not successfully verified (the status “Your documents have been checked and confirmed” is not received), this promo code burns out and its reuse, including after successful account verification, is not possible.
 - 3.10. Each promo code credits a certain amount in a certain coin, depending on the type of the promo code.
 - 3.11. The number of promo codes is limited.
 - 3.12. Each promo code is limited in time.
 - 3.13. Each promo code is limited in the number of uses.
 - 3.14. To receive a reward via a promo code, it is necessary to comply with all the terms of the Promotion and successfully complete KYC until the promo codes are available.
 - 3.15. Promo codes are subject to the provisions of the section of the Service User Agreement https://broex.io/assets/docs/terms_of_use.pdf.
 - 3.16. By participating in the Promotion, the User confirms that he is familiar with, agrees and accepts these Rules in full.
 4. Rights of the Participant
 - 4.1. Read the Terms of the Promotion.
 - 4.2. Take part in the Promotion in the manner determined by these Terms.
 5. Obligations of the Participant
 - 5.1. Comply with the requirements of these Terms and Conditions, as well as other requirements imposed by the current Estonian legislation in this situation.
 - 5.2. By participating in the Promotion, the Participant confirms that he is fully familiar with and agrees with these Terms.
 6. Obligations of the Organizer
 - 6.1. The organizer is obliged to credit remuneration to the participant if the participant of the Promotion complies with all the conditions specified in these Terms.



7. Rights of the Organizer

- 7.1. The Organizers have the right to change the Terms of the Promotion at any time without notifying the Participants.
- 7.2. The organizers have the right not to credit a reward according to a promo code or to cancel it if the Participant was noticed in fraudulent actions, did not successfully pass the account verification procedure, and for other reasons indicating a violation by the Participant of the conditions for holding and participating in the Promotion.
