<p>7. Terms of the promotion, procedure for participation and prize fund</p>	<p>7.1. To receive a reward in the form of 10% of the purchased amount of Partner's tokens, you must:</p> <p>7.1.1. Register or be a registered User on the site <a href="https://broex.io/">https://broex.io/</a>;</p> <p>7.1.2. Verify your account or have a verified account (in the settings of your personal account, the status "Your documents have been verified and confirmed" is received);</p> <p>7.1.3. Buy WELD tokens for at least 100 USD in equivalent;</p> <p>7.1.4. The accrual of remuneration will take place with the Partner's tokens 3 days after all the conditions of the promotion are fulfilled.</p> <p>7.2. Number of rewards: no more than 300 rewards;</p> <p>7.3. Number of participants: no more than 300 people;</p> <p>7.4. One reward denomination: 10% of the purchased amount of WELD tokens;</p> <p>7.5. <p>10. Obligations of the Organizer</p>	<p>10.1. The organizer is obliged to accrue remuneration to the participant if the participant of the Promotion observes all the conditions specified in these Terms.</p>
<p>11. Rights of the Organizer</p>	<p>11.1. The Organizers have the right to change the Terms of the Promotion at any time without notifying the Participants;</p> <p>11.2. The promotion may end earlier if the entire budget in the equivalent of 3,000 USD per share is distributed to users by December 8, 2021;</p> <p>11.3. The organizers have the right not to credit a reward according to a promo code or to cancel it if the Promotion Participant was noticed in fraudulent actions, did not successfully pass the account verification, and for other reasons indicating a violation by the Participant of the conditions for holding and participating in the Promotion.</p>
