When you enter a promo code, if your account is not verified successfully (the status “Your documents have been checked and confirmed” is not received), this promo code burns out and its reuse, including after successful account verification, is not possible;</p> <p>7.3. By participating in the Promotion, the Participant confirms that he is familiar with, agrees and accepts these Terms in full.</p> <p>7.4. Number of promo codes: 100 pieces;</p> <p>7.5. Number of participants: no more than 100 people;</p> <p>7.6. One promo code denomination: 1 USDT;</p> <p>7.7. One user can participate: no more than 10 times;</p> <p>7.8. The organizers have the right not to credit a reward according to a promo code or to cancel it if the Promotion Participant was noticed in fraudulent actions, did not successfully pass the account verification, and for other reasons indicating a violation by the Participant of the conditions for holding and participating in the Promotion.</p>
